# **Executive Summary**

Sacramento County is a partner in the Sacramento Public Library Authority that provides library services and operates libraries in the County. The County is responsible for planning, constructing, and financing library facilities within the county's jurisdiction. Impact fees levied on new developments provide a portion of financing available for library construction. Projects proposed to be completed in the Fiscal Year 2012-13 Capital Budget include an "Operating Budget Impact" statement.

The Capital Improvement Plan (CIP) budget is \$1.8 million. The following identifies a key project in the CIP for Fiscal Years 2012-13 through 2016-17.

## Fair Oaks Library

• **Replace Siding, Roof, and Water Damaged Carpet** - The Fair Oaks Library building was constructed in 1976. The exterior siding has deteriorated and the roof leaks and is beyond its serviceable life; both the roof system and siding must be replaced. Water intrusion has damaged the carpet and it must also be replaced. To preserve the architectural appearance of this facility, the siding will be replaced in-kind. This project is well under way and is estimated to be completed in 2012.

Estimated Total Cost: \$1,381,619
