

**RESOLUTION NO.**

**A RESOLUTION OF THE BOARD OF SUPERVISORS, COUNTY OF SACRAMENTO APPROVING THE RECOMMENDED BUDGET FOR FISCAL YEAR 2021-22**

**WHEREAS**, County offices, departments and agencies have submitted estimates of budget requirements for Fiscal Year 2021-22 and those estimates have been reviewed by the County Executive; and

**WHEREAS**, the County Executive has submitted the tabulations of said estimates together with proposed revisions to the Board of Supervisors; and

**WHEREAS**, the Board of Supervisors has reviewed and considered the Recommended Budget for Fiscal Year 2021-22

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** that the Recommended Budget for Fiscal Year 2021-22 as submitted by the County Executive and as revised by the Board of Supervisors, is a proper financial program for the budget period and constitutes the Recommended Budget for Fiscal Year 2021-22; and

**BE IT FURTHER RESOLVED AND ORDERED** that the Recommended Budget for Fiscal Year 2021-22 is hereby approved, and shall constitute authorization for County expenditures until adoption of the budget for said fiscal year; and

**BE IT FURTHER RESOLVED AND ORDERED** that hearings to consider the adoption of the Recommended Budget, as revised by the County Executive, for Fiscal Year 2021-22 shall commence on September 8, 2021 at 9:30 a.m., or as soon thereafter as practicable, in the Chambers of the Board of Supervisors at 700 H Street, Sacramento, California, and the Clerk of the Board of Supervisors is directed to cause the posting and publication of such notice as is required for said hearing; and

**BE IT FURTHER RESOLVED AND ORDERED** that pursuant to Government Code Section 29081, the hearing on the budget recommended for adoption shall not exceed a total of fourteen calendar days unless a written request to continue the hearings beyond that date is filed with the Clerk of the Board of Supervisors; and

**BE IT FURTHER RESOLVED AND ORDERED** that any revisions to the Approved Budget recommended by the County Executive for consideration at budget adoption hearings shall prioritize General Fund investment in programs and services identified in the Recommended Budget and in increasing General Fund reserves, resources permitting.
