On Wednesday, June 7, 2023, at 9:30 a.m. the Board of Supervisors will conduct hearings on the following subjects which may be taken in any order:

- Deliberations/Board Approval of Recommended Budget

If necessary, the Board of Supervisors will continue hearings and deliberations to 9:30 a.m. on Thursday, June 8, 2023, and Friday, June 9, 2023.
